

FEBRUARY IS AMD MONTH

February is recognized as AMD Month to help create awareness of Age-related Macular Degeneration.

Age-related macular degeneration is an eye disease that affects central vision. As the name suggests, age is a major risk factor for this disease and it is the leading cause of blindness in North American adults over the age of 50.

The central vision is affected as a result of waste build up at the center part of the back of the eye called the macula. The macula is responsible for detailed vision necessary for activities such as reading, driving, and recognizing people's faces. AMD can progress slowly in some individuals and rapidly in others. Therefore, it is important to get routine eye exams to detect it early on.



As future and current healthcare workers, it is important to be aware of some of the common signs of AMD including:

- Blurry or fuzzy vision.
- Difficulty recognizing familiar faces.
- Straight lines appear wavy.
- A dark, empty area or blind spot appears in the center of vision.
- Loss of central vision, which is necessary for driving, reading, recognizing faces and performing closeup work.

T2202 Frequently Asked Questions:

Q: Where can I get T4A for grants that I received under Student Loan Funding?

A: You can obtain T4A from StudentAidBC from your National Student Loan Service Centre dashboard

Q: I don't see all my payments?

A: The T2202 contains only amounts paid for classes attended in a calendar year (JAN-DEC 2022). The rest of your payment will be carried over into the next tax year if applicable. The T2202 is based on study period date not payment date.

Q: My start date and end date does not match my enrollment?

A: The dates on the T2202 pertains to the month that you were in study in the 2022 calendar year. For example, if your study period is SEP 2022 - MAR 2023. Your T2202 2022 will only show SEP -DEC. The rest will be carried forward in the next calendar year.

Q: I don't see any amount on my T2202?

A: Not all payments are eligible. Please refer to Canada Revenue Agency website regarding amounts which cannot be claimed as tuition fees.
